Timing: This is the first form to be completed for membership in the SAY Organization; this should be submitted as soon as possible.

Purpose: The purpose of this form is for New SAYAreas to complete and submit to the National Office for the National Board of Directors approval to join our organization. Not only does this form give us pertinent information such as the Area name and the date the application was submitted, but also the Districts within the Area as well the Geographical Boundaries for that given Area.

Additionally, this form signifies that there is an SAYAREA President, the President's contact information and, most importantly, that they agree to run their SAYArea in accordance with the requirements of the SAY National Program. Once submitted to the National Office, acceptance of the new SAYArea is verified when signed by the National Board of Directors President, and the National Board of Directors Secretary.
